 - 2024 -2025 Budget Approval Budget is based on the enrolment projections from January. Included in the budget is a wage increase for all support staff and artists, as well as the natural grid increase for teachers. If we see a teacher grid increase due to ATA's negotiations with the government and the government funds that increase, we will adjust our grid in kind. We have seen an increase in costs for transportation of around 47% as a worst-case scenario. We continue to negotiate

with Southland for the renewal of our contract. This budget will be updated in the fall when we finalize our enrollment.

- Education Plan The Education Plan is based off of the AERR from November and is part of the governments Assurance Model. The AERR includes education results as well as survey results from families, students and staff.
- Fee Policy update We are looking to tighten up the dates for families to pay all fees earlier, so we are not scrambling to collect prior to enrolment for the following year. This also provides us some recourse should fees not be collected by the end of the school year.
- Advocacy -Ken Met with Esmahan Razavi to tour the school and to gage interest on possibly joining the board as well. She worked for the NDP as Director of Outreach & Calgary Strategy Lead.

Capital Planning Committee Jim We are meeting with Larkspur for a project charter refresh, there was a proposal sent by Lori outlining different options, but we are meeting next week to furth discuss the proposal, and look at areas we might want to rethink. Larkspur is keen to help and has the capacity. We will come back to the board with the pricing and the details. Arsh has offered to help as well.
