- 6. Audit Committee Ken State of the finances: we are in good shape. We want to increase our unrestricted reserves a bit this year if we are able. We presented the fee guide to school council and they were happy to see no increase except for high school and graduation.

Motion 1 – Ken – To approve the 2024-2025 School Fees as presented – Doug Seconded – Motion Passed

We are looking at putting a policy together for dealing with delinquent accounts. If and when, we want to send to collections, etc. Doug will start on that and send to administration for review.

We met with Janice Boiko from Lloyd Sadd, for a breakdown of our liability coverage. After the meeting it was determined that we should increase our umbrella coverage by \$10,000,000. This would give us more coverage for general liability as well as more coverage for transportation. We also have Lukas updating our parent waivers for all our fieldtrips and the NY trip.

This has created a lot of discussion amongst charters. FFCA withdrew from TAAPCS as well as Westmount. Suzuki, Cape, and Mother Earth look like they might leave as well. Michelle made the difficult decision to resign from her role on the executive as did Ian Gray from Aurora.
